

## **Consent for personal data provision and processing**

I hereby acknowledge and give my free and voluntary consent to the company: PENTA d.o.o. I hereby acknowledge and declare that I am aware of my right to withdraw this consent in full or in part.

In the event of withdrawal of this consent in full, the Personal Database Manager shall cease any further processing of the Personal Data and delete it from the Personal Database. In the event of a partial withdrawal, this consent may be withdrawn in respect of providing the Personal Data to any or all Authorised Recipients, whether in respect to the export of the Personal Data to any or all countries, apart from the country of my residence, by submitting a request to that effect.

A consequence of denial of the Personal Data provision shall be the impossibility to take part in any marketing and other promotional activities or impossibility to achieve any benefits related to such activities.
